
### Position 02 - Barry Mandel

During this time, she spent many months collecting data in an isolated research station in French Guiana and coauthored a book entitled *Seed Dispersal by Bats in the Neotropics*.

In May 2010 she received her doctorate in Ecology and Evolutionary Biology from Columbia University. Cullen currently lives in Houston, works with her family on business matters and philanthropy, chairs the board of the Cullen Trust for Health Care, and serves on the Board of Directors of the Houston Zoo, the Houston Arboretum and Nature Center, Bat Conservation International, Blaffer Art Museum at University of Houston, the Houston Advanced Research Center, and the Houston Parks Board.
